**Explanation of Responses:**

The remaining 2,255,090 shares are no longer subject to vesting conditions but remain subject to disposal restrictions.
- Restricted Stock Units convert into Ordinary Shares on a one-for-one basis. This award will fully vest on April 30, 2030, subject to the reporting person's continued service.
